OPERATING AGREEMENT

OF

World Wide Widgets, LLC, LLC

SEPTEMBER 13, 2019

This Operating Agreement (this “**Agreement**”) is effective as of September 13, 2019, by Homer Simpson and Marge Simpson, as Trustees of the Camelback Mountain Trust under Agreement dated September 13, 2019 (the “**Trust**”); Ned Flanders, a married man dealing with his sole and separate property (“**Ned**”) and World Wide Widgets, LLC, LLC, an Arizona limited liability company (“**Company**”).

- A. The Company is a newly formed Arizona limited liability company.
- B. In this Agreement the Camelback Mountain Trust and Ned will be referred to individually as a “**Member**” and collectively as “**Members**.“ Ned will be referred to the “**Manager**.”
- C. The parties to this Agreement desire to conduct the business and affairs of the Company under the terms and conditions set forth below.

Article 1

Formation, Name, Purposes

Section 1.1 Formation

The Members formed a limited liability company (the “**Company**”) pursuant to Arizona Revised Statutes Sections 29-3101 through 29-4201, as amended from time to time, which statutes are known as the “Arizona Limited Liability Company Act” (the “**Act**”), effective upon the filing of the Articles of Organization for the Company with the Arizona Corporation Commission. The Members shall from time to time sign or cause to be signed all such certificates, fictitious name or business statements and other documents, and make or cause to be made all such filings, recordings and publishings, and do such other acts as the Managers may deem necessary or appropriate to comply with the requirements of law for the formation and operation of the Company in all jurisdictions in which the Company desires to conduct business. The Managers will cause the Company to be qualified or authorized to do business in any jurisdiction in which qualification or authorization is necessary to conduct the Company’s business.

Section 1.2 Definition of the Term Act

The term “**Act**” means and refers to Arizona Revised Statutes Sections 29-3101 through 29-4201, as amended from time to time, which statutes are known as the “**Arizona Limited Liability Company Act**.”
